How do we know that by-products fishmeals and oils are sustainable? Where something comes from plays a BIG part in that story, but how to we confirm where something comes from is also a science in itself.

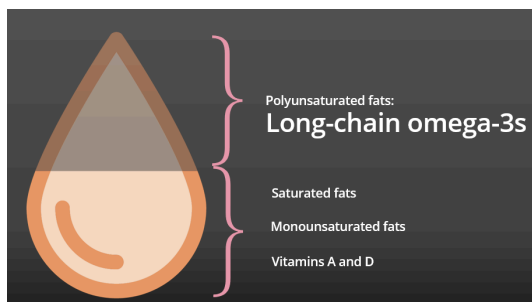

Between 70% to 90% of the footprint of feed is linked to its raw materials: anything we can do to improve what we use has significant impacts straight away.

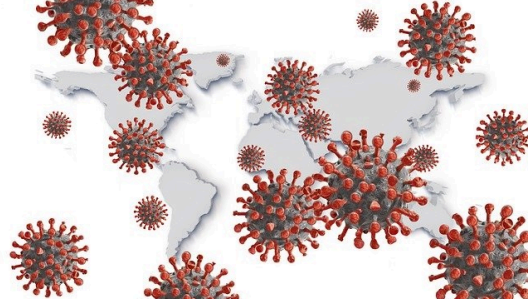
